#### **Information Items**

- 1. Mid-Year Financial Status Review Sherman Hu, Chief Financial Officer
  - CFO Hu presented the six-month year-to-date (YTD) actual-to-budget revenues which are at 49% and highlighted the differences for the individual facilities: airport; industrial park; and marinas (Port Orchard and Bremerton). He also provided the six-month YTD actual-to-budget operating expenses at 40% highlighting the differences for all facilities. The six-month YTD actual-to-budget for capital projects was provided with department heads providing status updates on the projects and responding to Board questions. CFO Hu closed by stating it is anticipated that the budget will be on target at the end of the year.
- 2. Kitsap County Disaster Airlift Response Team (DART) Exercise Recap Warren Hendrickson, Airport Manager

Mr. Hendrickson explained what the Disaster Airlift Response Team (DART) and Disaster Airlift Response Plan (DARP) are all about along with the purpose of the DART exercise which took place at Bremerton Airport on September 22, 2019. He introduced the cochairs of DART, George Steed and Diane Arnold, stating the exercise could not have happened without them. He displayed photos providing highlights of the exercise and responding to questions from the Board. He discussed exercise results by the numbers and next steps in the process. He responded to further questions and comments from the Board agreeing that this is a great way to connect the airport with the community and closed by thanking both the airport and marina crews for their assistance.

- Return Explore Port Orchard to \$1,000
- Increase Fathoms O'Fun Fireworks to \$6,000
- Move Kitsap Economic Development Alliance (KEDA) Decision Makers to operating budget
- Remove Kitsap Peninsula Water Trails \$250
- Move Legislative Luncheon to operating budget
